## 2007 Tax Rate Schedule for taxable income of \$100,000 or more

**Caution:** You must use the Tax Tables instead of this Tax Rate Schedule if your taxable income is less than \$100,000.

Use this rate schedule regardless of the filing status you checked on Form SC1040.

If the amount on SC1040 line 5, is **\$100,000 or more:**

Multiply the amount on line 5 by 7%;

Subtract \$448; and

Enter the difference on line 6.

### Example of Tax Rate Schedule Computation

If South Carolina income subject to tax on SC1040 line 5, is \$101,000 the tax is calculated as follows:

\$101,000	income from SC1040 line 5
X .07	(.07)
7,070	
- 448	subtraction amount (constant)
\$ 6,622	tax

\$6,622 is the amount of tax to be entered on SC1040 line 6 in this example.
