Fax-On-Demand: You may request forms through our Fax-On-Demand system by calling (803) 898-5320 (in the Columbia area) or toll-free within South Carolina 1-800-768-3676. Once in the system, you will need a Document Order Number to request forms. The **Document Order Number** for the **MENU** that lists all forms and their assigned numbers is **0001**. If you call from your fax phone, the system faxes the forms immediately. If you use a regular touch tone phone, the system will fax the forms after normal hours (11 p.m. - 8 a.m.). A maximum of six (6) forms may be requested in one call. The system will make three (3) attempts to fax the requested forms.
